- (1) from Dagger Draw, [I] 134.30¢ per barrel will be added; provided, however, that an incentive rate of [I] 98.49¢ per barrel shall be assessed to any Shipper that has entered into and has an effective dedication agreement with Centurion or any Shipper shipping on behalf of a producer that has entered into and has an effective dedication agreement with Centurion with respect to gathering and trunk line service from Dagger Draw to Artesia Station.
- b. When gathering is performed into Artesia from the following system, the rate indicated below will be added to the main line rates named above:
- from the Pecos System, Eddy County, New Mexico – [I] 133.63¢ per barrel.

Truck Unloading Fee
