When Crude Petroleum is moved from the Pecos System through Centurion Pipeline L.P.'s facility at Artesia Station into the Holly Refinery, a ~~25.92¢~~ per Barrel fee will be charged.

**(2) ~~Truck Unloading~~**

Where trucks are unloaded on Centurion Pipeline L.P.'s main line, a special handling charge of ~~28.77¢~~ per Barrel will be added to the trunk line rate in effect.

**(3) ~~Incentive Rate~~**

An incentive rate of ~~98.49¢~~ per Barrel will apply to any Shipper that has entered into and has an effective dedication agreement with Centurion or any Shipper shipping on behalf of a producer that has entered into and has an effective dedication agreement with Centurion with respect to gathering and trunk line service from Dagger Draw to Artesia Station.
