No gathering service will be performed under this tariff. The rate shown herein applies to trunk transportation only.

Notes:

- For the avoidance of doubt, applicable rates for crude oil transportation services will be charged on the net Crude Petroleum Barrel delivery quantities pursuant to Section 2, Rule 60 of the General Rules and Regulations published in Carrier’s TX No. 63.0.0, as measured by Carrier pursuant to the General Rules and Regulations published in Carrier’s TX No. 63.0.0, including supplements thereto and successive issues thereof, but prior to any adjustment or assessment for inherent losses, including but not limited to shrinkage, evaporation, interface losses and normal “over and short” losses.
- Only with respect to movements governed by this Rates Tariff, Paragraph 3 of Section 2, Rule 20 in Carrier’s TX No. 63.0.0 is amended and restated as follows:

A separate assessment of two-tenths of one percent (0.20%), on net quantities so determined for acceptance by Carrier for transportation on Carrier’s system, will be deducted to cover losses inherent in the transportation of Crude Petroleum.

\*\* The transportation movement from Plains Pipeline, L.P. Good Station or Plains Pipeline, L.P. Jo Mill Station, to North Howard Interconnect will have no assessment (0.00%) to cover losses.

**Pumping Charge**

- \* Carrier will assess a fee of seven and ninety-eight (7.98) cents per Barrel for any pumping services performed in order to effect deliveries into Sunoco Pipeline’s or BridgeTex’s pipeline at Carrier’s CC Facilities.
