Truck Unloading Fee

Where trucks are unloaded on the main line, a special handling charge of 28.70¢ per barrel will be added to the trunk line rate in effect.

A special handling charge of 25.92¢ per barrel will be added to the trunk line rate in effect for truck receipts made into the Albert, Artesia, Bretch, Childress, and Lewis Truck Stations for further transportation under this tariff.

Notes

- (1) The Quality of Crude Petroleum received at these locations for delivery to Cushing, Oklahoma may only be Domestic Sweet/West Texas Intermediate (WTI) with a sulfur content of 0.4% or less.
- (2) When gathering service is performed, 132.87¢ per barrel for AWC GS will be added to the AWC Station trunk line rate named in the above Table of Rates.
- (3) When gathering service is performed from Dagger Draw, 134.30¢ per barrel will be added; provided, however, that an incentive rate of 98.49¢ per barrel shall be assessed to any Shipper that has entered into and has an effective dedication agreement with Carrier or any Shipper shipping on behalf of a producer that has entered into and has

an effective dedication agreement with Carrier with respect to gathering and trunk line service from Dagger Draw to Artesia.

- (4) When gathering is performed into Artesia from the Pecos System, Eddy County, New Mexico, 133.63¢ per barrel will be added to the trunk line rate in effect.
- (5) An incentive rate of 37.50¢ per barrel will apply to any Shipper that has entered into and has an effective throughput and deficiency agreement with Carrier with respect to trunk line service from Cushing to Childress.
