**Unloading Charges:** All shipments unloaded from tank trucks into Carrier's trunk line facilities will be subject to a charge of **[I] thirteen and one-tenth cents (13.1¢)** per barrel. All shipments unloaded from tank trucks into Carrier's gathering facilities will be subject to the applicable gathering charge for said gathering facility. Such charges will be in addition to trunk transportation rates published in applicable tariffs.

**Loading Charges:** All shipments loaded from Carrier's trunk line facilities into tank trucks will be subject to a charge of **[I] thirteen and one-tenth cents (13.1¢)** per barrel. Such charges will be in addition to trunk transportation rates published in applicable tariffs.

**Deductions:** See Item No. 40 of Rules and Regulations.

**Note:** The following applies only to referenced origins and destinations as indicated on schedule:

- (1) The Sweet Crude Oil Sulfur content for receipts at these origin points and deliveries at this destination point cannot be greater than twenty-eight hundredths of one percent (0.28%) by weight.
- (2) Light Crude Oil only – API Gravity between 35 degrees and 45 degrees.
