**Exception to Rule 31, TX No. 1.6.0, Measurement, Testing, Volume Correction and Deductions – Crude Petroleum:** No deduction will be made to cover evaporation, interface losses or other normal losses during transportation.

**Exception to Rule 34, TX No. 1.6.0, Proration:** The “ETP Crude LLC Proration Policy PANS Pipeline” effective April 1, 2023 (the “Proration Policy”) will be provided upon request by the person listed as “compiler” on the title page of this tariff, and may be updated at any time to comply with applicable law or as may be necessary to comply with upstream or downstream connecting carrier requirements or its own operational requirements. The Proration Policy will govern prorationing of the Pipeline in place of Rule 34.

**Explanation of Reference Marks**

[I] Increased
