**Injection Points ("INJ.")**

The gathering charges in the table of rates for the above origin points designated as injection points ("Inj.") are for the movement from the gathering system to the trunk line injection point. The trunk line rates for these injection points are for the movement from the injection point to the Childress Station.

**Truck Unloading Fee**

Where trucks are unloaded on the main line, a special handling charge of 28.77¢ per Barrel will be added to the trunk line rate in effect.
