ROUTE: Mid Valley Pipeline Company LLC’s interest from Longview, TX to Haynesville, LA; then ETP Crude LLC from Haynesville, LA to 12” Lion Oil Pipeline Connection, Claiborne Parish, LA.

*The incentive rate will apply to any shipper that has executed a Transportation Services Agreement (TSA) with Carriers on or before January 31, 2021 committing to ship, or pay a deficiency for failure to ship, a minimum quantity of 5,000 barrels per day of crude petroleum for a minimum term of thirty (30) months. Any shipper that desires to review the form TSA must first execute a confidentiality agreement. A confidentiality agreement may be obtained by contacting the tariff compiler via email at tariffs@energytransfer.com. Once the confidentiality agreement is executed, the tariff compiler will deliver the form TSA to the interested shipper.

Explanation of Reference Marks

[I] Increased
