Such service will be capped at approximately 15,000 barrels per day of capacity.

- (b) Committed Rate 2 will apply to any shipper that has executed a new Pipeline Throughput and Deficiency Agreement (“T&D Agreement”) with Carrier on or before December 31, 2026, committing to ship a minimum volume of Petroleum for a minimum period of time. Any shipper that is interested in shipping Petroleum pursuant to such committed rates may review the form T&D Agreement after executing a confidentiality agreement. A confidentiality agreement may be obtained by contacting the tariff compiler via email at tariffs@energytransfer.com. Once the confidentiality agreement is executed, the tariff compiler will deliver the form T&D Agreement to the interested shipper.

Routing: Inland Corporation from either Toledo, Lucas County or Lima, Allen County, Ohio to Sunoco Pipeline L.P. at Fostoria Station, Hancock County, Ohio, then via Sunoco Pipeline L.P. to final destination.
