~~The rate for priority service applies to a shipper that executed a Throughput & Deficiency Agreement with White Cliffs Pipeline, L.L.C. committing to ship a minimum quantity of Crude Petroleum for five years. White Cliffs Pipeline, L.L.C. held open seasons from September 21, 2012 through October 24, 2012 and from August 15, 2014 through September 5, 2014, offering prospective shippers priority service at the premium rate and on the terms contained in the executed Throughput & Deficiency Agreements.~~

A pro forma copy of the transportation services agreement shall be provided to any interested Shipper upon the execution of a confidentiality agreement.

**Pumping Charge**

For deliveries out of the White Cliffs system to connecting terminals or pipelines at Cushing, when pumping services are provided by ET Crude Oil Terminals, LLC, a charge of [U] **8.62 cents per barrel** will be charged to Shipper.
