White Cliffs' interest from Platteville, Colorado to Cushing, Oklahoma; then Centurion's interest from Cushing, Oklahoma to the ETP Crude interconnect downstream of Wheeler, Texas near Roosevelt, Oklahoma; then ETP Crude's interest from the interconnect downstream of Wheeler, Texas near Roosevelt, Oklahoma to Ringgold, Texas; then PEP's interest from Ringgold, Texas to Nederland, Texas.

The committed rate set forth in the table above shall apply to any Shipper that executes a transportation services agreement with Carrier on or before February 29, 2024, pursuant to which such Shipper agrees to ship, or otherwise pay for not shipping, a minimum volume of 10,000 barrels per day.
